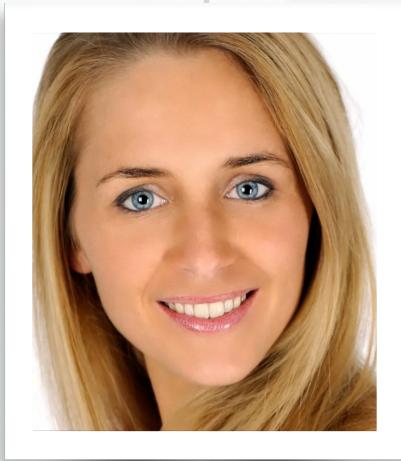


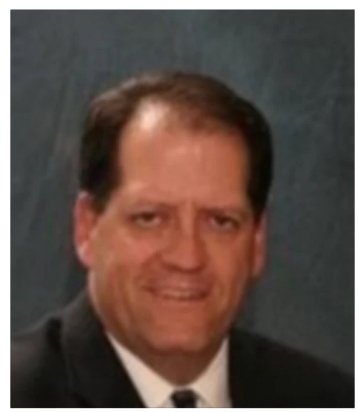

ORGANIZATION CHART

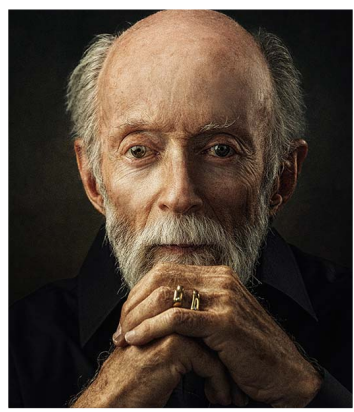

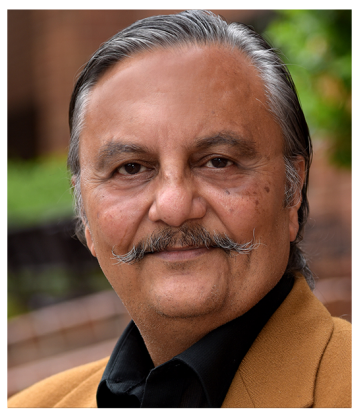
